Format: 18-Hole Stroke Play Competition
Thursday, July 21, 2011 One round, 18 holes

Sudden-death playoff to determine overall champion, low professional and low amateur, immediately upon the completion of play, if necessary. Overall champion and professional and amateur medalists receive trophies.

Eligibility: Professionals and amateurs who have reached their 18th birthday by May 21. Amateurs must have up-to-date and verified USGA handicap index not exceeding 8.4.

Deadline: Thursday, July 14, 2011 at 4:00 pm or the first 120 entries.

Entry Fee: \$250.00 for professionals \$125.00 for amateurs \$300 Non-PGA Professionals
Make check or money order payable to the "Crumpin-Fox Club". **Telephone or fax entries accepted only if accompanied by a major credit card.** The entry includes course charge, range balls, on course beverages.

Estimated Prizes: Based on a field of 100 competitors, the total estimated prize & awards purse for the Western Mass. Open is approximately \$12,000 (*\$11,000 for professionals prizes and \$1,000 for amateur prizes).

Western Mass. Open Championship (Thursday, July 21, 2011)

- RULES OF GOLF:** Play will be governed by the Tournament Rules Committee, USGA Rules of Golf, and a local supplementary Rules of Play sheet. All questions will be settled by the Rules Committee, whose decision shall be final. The competition shall be deemed to have closed when the Championship trophy has been presented.
- STARTING TIMES:** Thursday, July 21; starting times begin at 7:30 AM, and will be assigned by the Tournament Committee. Starting times will be posted at golfthefox.com and www.ctpga.com on July 20th.
- REGISTRATION:** All competitors should check in at registration prior to their starting time.
- PRACTICE ROUND:** Crumpin-Fox Club is a semi-private golf course and welcomes public play. Please call the golf shop at 413-648-9101 for rates and starting time availability.
- GOLF CARS/CADDIES:** The use of golf cars for the Western Mass. Open competition is not mandatory and caddies will be permitted. Caddies do not have to carry the competitors' clubs and will be permitted to use a golf car. However, only 2 golf cars may be permitted per group. No spectators are permitted to ride in cart.
- DRESS CODE:** Professionals must wear slacks, collared shirts; Amateurs and caddies may wear Bermuda length shorts. All participants (and caddies) will be required to present a neat appearance, appropriate to a professional golf tournament in both clothing and grooming.
