Eligibility

Entries are open to female professional and amateur golfers. Amateurs must have up-to-date USGA Handicap Indexes not exceeding 10.0. Note: The limit is a USGA Handicap of 10 if the club follows the USGA Handicap System but does not have a slope rating. Golf Professionals who are PGA or LPGA Club Professional affiliated. LPGA and Futures Tour Players are not eligible to participate.

Entries

An entry fee of \$200.00 for professionals and amateurs shall be paid by every player. Payment must be in the form of a check or money order made out to New England Womens Golf. Deadline is June 15th by 5 pm.

Schedule

Competition will be at stroke play.

Championship – 36 holes.

Monday June 27th – First Round, 18 holes with tee times starting after 7:30 am.

Tuesday June 28th – Second Round, 18 holes with morning tee times to be determined.

Lowest scorer for 36 holes will be declared the champion. In the event of a tie for the championship, there will be a hole-by-hole play-off immediately following completion of play.

Footwear

It is a condition of the competition that shoes with traditionally-designed spikes (regardless of composition, i.e. ceramic plastic, etc.) or spikes, regardless of design, comprised either or entirely of metal (when such metal comes into contact with the surface of the putting green) are prohibited. Penalty for breach of this condition: Disqualification.

Rules of Golf

Play will be governed by the Rules of Golf as approved by the USGA.

Caddies

A player may provide her own caddie. A player is not required to employ a caddie. Automotive transportation is permitted. PLEASE inform the Committee if you will be using a golf cart.

Time of Starting

The optional condition for time of starting prescribed in Appendix I of the Rules of Golf shall be in effect.

Practice Rounds CARTS WILL BE MANDATORY for all Practice Rounds. Cart Fee \$20.00 per player. Practice Rounds will be for the PLAYERS ONLY.
