



- FORMAT:** Round Robin; Divisions, Four-Ball Match Play, 18-Hole matches (matches must be played to completion).
- SCORING:** Three (3) points will be awarded for the winner of the front nine, three (3) points will be awarded for the back nine, and three (3) points will be awarded for the overall match.
- TEAMS:** 2-person Teams of PGA Members as defined by Article IV, Section 1, in good standing only. PGA Professionals must partner with a professional from another facility, professionals that enter as singles will be randomly paired.
- DIVISIONS:** Teams will be randomly assigned to a division with five (5) other teams (6 teams total per division).
- ENTRY FEE:** \$75.00 per person.
- LEAGUE CHAMPIONSHIP:** Thursday, October 6, 2011, Hop Meadow Country Club, all teams qualify for the season-ending League Championship. The format for the League Championship will be an 18-hole modified alternate shot competition. Points will be awarded based on the League Championship place finish.
- PRIZES:** A portion of the entry fees will go to the PGA League Championship prize purse and a portion of the entry fees will also go to the PGA Professionals Golf League division winners.

SCHEDULE: Each team will play one match with each of the 5 teams in their division. The matches will be arranged randomly by the section and posted on the section website. The team on top is designated as the “home” team. The home team is responsible for initiating the scheduling of the match with the mutual acceptance of the away team. Matches may be scheduled at any PGA employed golf course but must be completed before designated completion dates below. Players are responsible for any course fees, if applicable, at any match.

Match One: Must be completed between:
Monday, April 25 and Tuesday, May 31

Match Two: Must be completed between:
Sunday, May 1 and Thursday, June 30

Match Three: Must be completed between:
Wednesday, June 1 and Sunday, July 31

Match Four: Must be completed between:
Friday, July 1 and Wednesday, August 31

Match Five: Must be completed between:
Monday, August 1 and Friday, September 30

SCORE KEEPING: The home team will be responsible for reporting the results of the match (to the section office) within 48 hours of the match completion. Please report all scores to the section office.

SUBSTITUTIONS: A substitution may be permitted under the following conditions: The substitute must be a PGA Member and not already on an existing team in the PGA Professional Golf League. A team may only use a substitute twice throughout the season. The team using a substitute is deducted three (3) points at the completion of the match.

SUSPENSION OF PLAY: In the event that an 18-hole match cannot be completed, the match will revert to 9-holes. The winning team will receive six (6) points for winning the 9-hole match.

FORFEIT POLICY: If a match cannot be attempted or scheduled, the team in question must forfeit. The winning team will be awarded six (6) points for the victory.

LEAGUE
CHAMPIONSHIP:

Thursday, October 6, 2011 (1:00 PM Shotgun), Hop Meadow Country Club, all teams qualify for the season-ending League Championship. The format for the League Championship will be an 18-hole modified alternate shot competition. Points will be awarded based on the PGA League Championship place finish (breakdown below, based on 32 teams).

The points earned during the round robin match play portion of the PGA Professional Golf League will carryover into the season-ending League Championship.

All division winners will receive \$200 (\$100 each). The PGA League Championship prize breakdown is listed below.
